Refunds:

Bitches in season are not allowed on the test grounds. Refunds will be made for bitches in season or injured dogs, if a veterinarian's certificate is provided to the Test Secretary no later than the morning of the event.

Directions to Sugarfoot Kennel:

From the South: Take exit 138 Clinton off of Interstate 95 (bear right). Continue on Hinkley Road to Stop Sign. Turn left onto Rt 100/11. Travel to the center of Burnham, just past the railroad tracks, turn right onto the Troy Road. Shortly after a 4-way intersection with Horseback Road, Sugarfoot Kennel will be located on the left. CAUTION: Blind Hill

From the North: From I-95, take exit 150 into Pittsfield. Take a right onto Rt 100/11. Turn left onto Peltoma (eventually becomes Horseback Road). Take a left onto Troy Road, shortly Sugarfoot Kennel will be on your left. Signs will be posted.
